TARGET: 1.5.6 By 20xx, create sustainable financial mechanisms to finance transboundary water institutions.

Target Rationale

Effective management of transboundary water resources requires functioning regional management institutions or transboundary cooperative frameworks on shared water bodies or aquifers, capable of facilitating cooperation amongst states sharing the water resource and implementation of common strategy and joint management policy. Appropriate financing of transboundary cooperative frameworks and transboundary water management institutions , in particular cost of establishing and maintaining of the institutional arrangements, capacity building, developing a legal framework, management (including monitoring, data sharing and assessment), and supporting implementation of joint programmes to optimize equitable use and protection of the shared water body or aquifer need to be funded on a sustainable basis.

Financing of transboundary water management cooperation varies largely across the globe, utilising mixture of financing tools and mechanisms: from national budgets and externally funded projects to more strategic programmes and funds or private public partnerships.

The level of financing of cooperation varies broadly from one transboundary water body or aquifer to another. The amount of accessible financial resources, chiefly coming from limited available national budgetary resources, in most cases do not meet the financial needs to sustain cooperation on shared water body or aquifer and/or transboundary institution. Therefore, complementary and innovative funding mechanisms need to be added to existing ones, expanding participation and of all stakeholders sharing the common objective of equitable management of the transboundary water resource.

Target Description

Sustainable and financially viable regional institutions or transboundary cooperative frameworks are critical for long-term transboundary cooperation in management of shared water body or aquifer. All traditional and innovative financing mechanisms, e.g. user/polluter-pays principle, financing solidarity, payment for ecosystem services, inter-riparian financing, etc. should be considered as options providing sustainable financing to transboundary

management institutions or transboundary cooperative frameworks facilitating joint management of shared water body or aquifer and supporting implementation of regionally agreed policies. Many of these more advanced financing mechanisms would require strong political support and establishment or strengthening complex institutional structures.

Adding new complementary funding systems into the existing and designed funding schemes of transboundary management institutions is a complicated process depending of right mix of tools and effective policies at national and regional levels, including understanding and support of all shared basin or aquifer stakeholders. Championing of these new approaches in number of targeted international institutions would have multiplication effect on other less mature organizations or transboundary cooperative frameworks as well as allow to document, analyse and broadly disseminate success stories and lessons learned across 270+ transboundary river and lake basins and 200+ transboundary aquifers.

In many parts of the world, the financial needs of existing and future transboundary institutions are well beyond the capacities of countries and national authorities involved. To overcome these regional financial barriers to sustainable financing of those institutions, higher level of support focused on transboundary basins and aquifers management institutions would be facilitated through achieving this target.

Broader recognition and understanding of the role and responsibilities of national water authorities and institutions in long-term cooperation on shared water bodies, their technical and financial capacities to actively participate and contribute to sound and sustainable management of transboundary water resource is one of the critical conditions for stable institutions and cooperation.

However, Niger Basin Authority have submitted one innovative solution on use of political approach to achieve sustainable funding mechanism for key functions of the NBA through growing "basin public service " missions that are by nature meant to be sustainable: planning and coordination of large dams projects, monitoring and hydrological forecasting, water allocation, environmental monitoring. Number of partners in the network e.g. ICPDR, Lake Victoria Commission, Sava Commission, IW:Learn, etc. are still being encouraged to propose more solutions based on their successful experience.
