

## Cooperation in transboundary waters

More than half of world population depends every day on water resources shared among several countries. It is crucial to organise the joint cooperation and management of these resources at scale of transboundary basins of rivers, lakes and aquifers, with the support of efficient transboundary basin organisations.

Numerous examples of good practices of integrated management of transboundary water resources exist in the world. It is necessary to take advantage of this experience and to promote the instruments and management systems which are well working through existing basin organisations.
