- Problematic sessions may have issues in three aspects: (PLEASE AVOID IT)
- 1) A session is dominated by a particular institution or only a few members
- 2) Session design is inadequate in terms of session titles, description, time allotment, program, and so on
- 3) All the stakeholders who have appealed intentions of participation do not sufficiently get involved in a session.

2. Theme 1.2

- TPC is happy with your proposals. Thank you for your efforts. Please proceed and keep incorporating approaching institutions.

3. Theme 1.3:

- Having two sessions under one title is unsuitable especially when two sessions are alike and combining two sessions is expected to result much interesting and comprehensive session. In this regards, please merge 2 proposals for issue 1.3.3 and issue 1.3.5 into one session by reaching a compromise between 2 potential SGs for each issue. Creative session design is required.
- TPC much highlights significance of subject 'climate change'. It seems issue 1.3.1, 1.3.2, 1.3.3 deal with 'disaster' while issue 1.3.4, 1.3.5 address 'climate change'. If the DG needs, you can have additional session for 'climate change'. Since your group already suggests two sessions for 1.3.5, one of them could be converted into 1.3.6 session. But it should be differentiated from 1.3.5 and should address important issue regarding climate change.

4. Theme 1.4:

- It is strongly recommended that the DG 1.4 communicate more vigorously in order to set up proposals confirmed by every member.
- * As DG 1.4 submits their proposals after this TPC meeting, it will be reviewed in November and will be notified.

5. Theme 2.1:

- TPC is happy with your proposals. Thank you for your efforts. Please proceed and keep incorporating approaching institutions.
- Issue 2.1.1 needs to be linked to the Science & Technology Process. If no intention, it should be differentiated from sessions within the S&T Process.

6. Theme 2.2:

- TPC is happy with your proposals. Thank you for your efforts. Please proceed and keep incorporating approaching institutions.

7. Theme 2.3:

- Issue 2.3.1 needs a stronger session title.
- Issue 2.3.3 can consider the possibility of linkage and coordination with Theme 4.5

- In order to make sure, 2.3.6 joint session is not an additional thematic session. Rather it is one of session within Science & Technology Process but is labeled as 'joint session' and listed in Thematic session list as well.

8. Theme 3.1:

- TPC is happy with your proposals. Thank you for your efforts. Please proceed and keep incorporating approaching institutions.

9. Theme 3.2:

- Please submit session proposals within three days. Please ensure all the group members work with the DG 3.2 coordinator in session design. If not, the TPC will consider finding other group members who can proceed with a task in order to secure outcomes of Theme 3.2.

10. Theme 3.3:

- TPC is happy with your progress. But we are still waiting for a proposal for 3.3.2.

11. Theme 3.4:

- For Issue 3.4.1, a title needs to be modified. It isn't appropriate to emphasize 'transboudary' itself in a title because it may confuse people with sessions in Theme 4.3 'Cooperation for reducing conflict and improving transboundary water management'. In addition, more institutions and organizations should be involved for the SG 3.4.1. TPC regards the 'joint management' as the subject which especially more stakeholders should be involved.
- For Issues 3.4.2, the geographic scope should be expanded to other transition countries. And a few working group members need to be state with a title of organization or institution instead of individuals.
- Issue 3.4.3 should submit a session proposal as soon as possible.
- For Issue 3.4.4 more institutions and organizations should be involved for the SG 3.4.4. Also, a title needs to be modified with focus on how knowledge tool will realize the implementation of IWRM.
- Issue 3.4.5 should submit a session proposal as soon as possible. The TPC recommends Issue 3.4.5 need to focus on how to change an approach to IWRM in order to accord with the SDGs.

12. Theme 4.1:

- TPC is still waiting for your response to prior feedback of TPC.

"Issue 4.1.6 and concluding session are significantly similar. Please, and please be sure to merge these sessions into 1 concluding session or to differentiate them from each other"

13. Theme 4.2:

- TPC is happy with your proposals. Thank you for your efforts. Please proceed and keep incorporating approaching institutions.

14. Theme 4.3:

- Regarding 4.3.2, if your intention was beyond just NEXUS issue, please proceed. If you intend to submit a special session, please do as soon as possible. TPC strongly recommends the special session proposal to be focused on the global legal framework such as the 1997 UN Convention.
- Thanks for your clarification regarding 4.3.5. We are happy with the changed title.

15. Theme 4.4:

- TPC is happy with your proposals. Thank you for your efforts. Please proceed and keep incorporating approaching institutions.

16. Theme 4.5:

- The SG for Issue 4.5.1 seems to be dominated by a particular organization, UNESCO. It needs to include additional members who have revealed intentions of involvement.
- The SG for Issue 4.5.3 seems to be dominated by a particular organization, INWTC. It needs to include additional members who have revealed intentions of involvement.
- While the SG for Issue 4.5.4 exhibits enormous number of members, almost every institution seems to be members of INBO. It needs to include additional members who have revealed intentions of involvement.
- Please be sure to vary the scope of participants in terms of geography and character of institution.
