KEY MESSAGES AND RECOMMENDATIONS



- ► NEED FOR EDUCATION AND CAPACITY BUILDING IN WATER DIPLOMACY TO BE PRIORITISED
- ➢ NEED FOR CHAMPIONS FROM WITHIN THE RIPARIANS TO ADVANCE THE PROGRESS OF WATER COOPERATION
- ► NEED TO RECOGNISE THAT WATER COOPERATION AND DIPLOMACY ARE SOCIAL PROCESSES
- ➢ NEED TO ENGAGE WITH LOCAL COMMUNITIES TO COLLECTIVELY FIND APPROPRIATE AND MEANINGFUL SOLUTIONS TO WATER PROBLEMS
- ► NEED TO CONTEXTUALISE WATER DIPLOMACY EFFORTS FOR **EFFECTIVE** COOPERATION
- ► NEED FOR COHERENT LEGISLATION BETWEEN RIPARIANS
- ► NEED TO EXPAND THE SOLUTION SPACE TO INCLUDE NON-STATE ACTORS IN WATER ALLOCATION AND MANAGEMENT DECISIONS
- ➢ NEED FOR GOVERNANCE STRUCTURES TO ACCOMMODATE THE INCREASING FOCUS ON TRANSBOUNDARY WATER INVESTMENTS AND A NEED TO INCLUDE FINANCE AND BUSINESS ACTORS IN DEVELOPMENT DIALOGUE
